RESERVATIONS: A signed application, including NUMBER OF PERSONS OCCUPYING UNIT AND 50% RENTAL DEPOSIT, is required to reserve a Unit. If you have multiple choices with varying deposits, please enclose an estimated deposit amount with your Reservation Application. Once your reservation choices are finalized, any deposit shortfalls or overpayments can be corrected. A written Reservation Confirmation will be issued once your application and deposit is received, and we have ensured that we can accommodate your choice of accommodation and dates.

THREE or MORE CONSECUTIVE WEEKS in the same house: Reservation requests will be accepted by telephone at any time. Signed applications and deposits for telephone reservations must be received within one week to confirm a reservation.

ONE and TWO WEEKS: Reservation requests, with signed application and 50% deposit, are accepted BY MAIL ONLY until February 18, 2012. Reservation requests are welcome by telephone/email AFTER February 18, 2012. Signed applications and deposits for telephone reservations must be received within one week to confirm a reservation.

PAYMENT POLICY: Personal checks are accepted for all reservation deposits. If you have multiple choices with varying deposits, please enclose an estimated deposit amount with your Reservation Application. Once your reservation is finalized, any deposit excess or shortfall can be corrected. Final Payment, including rental balance and security deposit, must be received no later than 2 weeks prior to Arrival date, and may be paid by personal check. Final Payments received less than 2 weeks prior to Arrival date must be paid by cash, traveler's checks, certified check or money order.

SECURITY/CLEANING DEPOSIT: A security/cleaning deposit will be collected with the Final Payment for each unit. Houses will be inspected for DAMAGE and/or EXCESSIVE CLEANING after check-out. SECURITY DEPOSITS WILL BE RETURNED BY MAIL AFTER CHECK-OUT.

CANCELLATION POLICY: In the event of a cancellation, for any reason, all deposits will be refunded, minus a \$100.00 processing fee, ONLY if the property is re-rented under the same terms and conditions as the original rental. If we are unable to re-rent the property, all deposits will be forfeited to the Owner of the property. No refunds will be given in the event of hurricanes or other natural events. We highly recommend that you purchase travel insurance.

OCCUPANCY LIMIT: Occupancy (including small children, infants and visitors) is not to exceed the occupancy limit for the unit. If more than the maximum number is found to be occupying the unit, the rental will be immediately terminated without refund and the security deposit forfeited. OCCUPANCY LIMITS ARE STRICTLY ENFORCED.

Tenant shall not violate Chapter-108 OCCUPANCY OF BUILDINGS, BY-LAW TOWN OF YARMOUTH with regard to exceeding the occupancy limit as specified by the Yarmouth Board of Health for the property. Tenant further agrees to indemnify owner and rental agent (Great Island Ocean Club) with respect to any occupancy limit violation occurring during the term of tenancy by tenant of said property.

N.B.: Among other things, Chapter 108 specifies that each days' violation is a separate offense, and that 1st offense - \$50.00, 2nd offense - \$100.00, 3rd offense - \$200.00. Applies to "Owner", "Agent" or "Tenant."

ON-SEASON/OFF-SEASON: On-Season rates will apply from Saturday, June 23 - Saturday, September 1, 2012. The pool is open during On-Season only. Off-Season rates will apply prior to Saturday, June 23 and after Saturday, September 1, 2012. The pool is not open during the Off-Season.

CHECK-IN/CHECK-OUT TIMES AND DATES: The rental week is from Saturday to Saturday. Check-In time is between 3:00 - 5:00 p.m. GIOC Security will not allow incoming tenants entrance into GIOC prior to 1:00 pm on Saturday. Sorry, no keys will be given out until 3:00 p.m. Check-Out time is prior to 10:00 a.m. and is strictly enforced. Failure to vacate the unit at that time will result in a security deposit deduction.
